Articulation/Transfer Agreement Martin Methodist College

And

Motlow State Community College

This Articulation Agreement is entered into on this April 25th 2017, by and between Martin Methodist College (MMC) and Motlow State Community College (MSCC). The parties desire to enter into a contract pursuant to which students at MSCC will be eligible for articulated course credits at MMC.

Accordingly, in consideration of the promises and mutual covenants contained in this Agreement, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. Description of Articulation Program.
 - a. **Purpose**. The purpose of this Agreement is to facilitate the transfer of MSCC students to MMC; to provide specific advisement for MSCC students who intend to transfer to MMC; and to encourage academic and administrative coordination between the institutions.
 - b. **Semester Meetings**. MMC commits to holding meetings at MSCC each year to address questions and facilitate the transfer process.
 - **c. Annual Review.** This agreement will be subject to annual review by representatives of each institution. Any recommendations for revisions will be made in writing and reviewed by each institution's Provost or their designees.
 - **d. Admissions Requirements.** MSCC students wishing to transfer credits to MMC within one of its 38 four year Degree Programs must meet the admissions requirements for MMC. These students must also provide MMC with an official transcript from MSCC. If admitted, the students will be subject to all MMC policies, rules and procedures.
 - **e. Focus on Articulation.** This Agreement is in keeping with the Tennessee Board of Regents focus on partnerships and collaboration between TBR institutions.

- **f. Term.** This agreement will be effective from the date on final signature below, the effective date, until terminated in writing by either party. It is agreed that if terminated both institutions will honor the terms of this Agreement until the end of the next admissions application and review period by MMC.
- **g. Post Termination.** If this Agreement is terminated for any reason, MSCC students previously accepted by or admitted to MMC shall continue to receive the benefits by this Agreement.
- h. Non Discrimination. Both parties shall abide by all applicable Federal and State law pertaining to discrimination and hereby agree and assure that no person shall be excluded from participation in, be denied benefits of, or otherwise be subjected to discrimination in the performance of this Agreement or in the employment practices of the party on the grounds of classifications protected by Federal or State law.

General Terms and Conditions

• Martin Methodist College and Motlow State Community College agree that in the performance of this articulation agreement they will comply with Titles VI and VII pf the Civil Rights Act in 1964, Title IX of the Educational Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, Executive Order 11,246, the Americans with Disabilities Act of 1990 and the related regulations to each. Each party assures that it will not discriminate against any individual including, but not limited to, employees or applicants for employment and/or students or applicants for admission as students on the basis of race, religion, creed, color, sex, age, disability, veteran status, national origin, or any other classification protected by Federal, or Tennessee constitutional or statutory law.
